

### **January 9, 2026, Probate Tentative Rulings**

**1. P07-14542 In the Matter of Michael A. Powers, et al.**

Appearances are required. Trustee Lisa Case shall show cause why she should not be sanctioned for failure to file a declaration clarifying the property on hand at the end of the reporting period as ordered by this Court on June 20, 2025.

**2. P17-16154 In the Matter of Dawn Delange**

No appearances are required. The conservatorship of the person shall continue. The conservatorship still appears to be warranted. The Conservators are acting in the best interests of the Conservatee regarding the Conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for January 7, 2028, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.

**3. PR0000117 In Re Christopher Hogue**

No appearances are required. Conservator has now provided sufficient notice of the accounting. The first account and report of conservator is granted as prayed. Conservator shall submit a proposed order. The order to show cause issued to Heather Hogue is discharged in the interests of justice.

**4. PR0000547 In the Matter of Quita Ann Blevins**

No appearances are required. The petition to administer the estate is granted as prayed. Petitioner shall submit a proposed order.

**5. PR0000616 In the Matter of Allison G. Sprader**

No appearances are required. The petition for settlement of first account and report of conservator and allowance of fees to attorney for conservator and request to exempt future accountings is granted as prayed. A proposed order has been submitted.

**6. PR0000623 In the Matter of Susan Lesley Vega**

No appearances are required. On its own motion, the Court continues this matter to March 20, 2026, at 9:00 a.m., in Department 6. Petitioner had previously requested additional time to file an amended petition and/or supplement to the First and Final Report, Account and Petition. The Court has not received any additional filings. Accordingly, Petitioner shall file their amended petition or a declaration indicating the status of the present petition no later than two weeks prior to the continued court date. Petitioner shall provide notice of the continued court date.

**7. PR0000759 In the Matter of the Renfro Family Trust**

No appearances are required. At the request of the Petitioner, the Court continues this matter to March 20, 2026, at 9:00 a.m., in Department 6. Petitioner shall provide notice of the continued court date.

**8. PR0000824 In the Matter of Keith Dean Emmerton**

No appearances are required. The Court has not received the requested capacity

declaration. Accordingly, the Court continues this matter to March 20, 2026, at 9:00 a.m., in Department 6 for receipt of the same. Petitioner shall provide notice of the continued court date.

**9. PR0000844 In the Matter of Janet Schaper**

No appearances are required. The Court continues this matter to March 20, 2026, at 9:00 a.m., in Department 6 to permit the parties time to complete mediation. No later than two weeks prior to the continued Court date, the parties shall submit a joint statement providing an update on the outcome of mediation.

**10. PR0000885 In the Matter of Charles Edward Penna**

No appearances are required. The Court continues this matter to March 20, 2026, at 9:00 a.m., in Department 6. The Court is favorably inclined to grant the petition to administer, however, the Court seeks clarity whether named executor Bonny Jean Penna has declined to serve as administrator. At least two weeks prior to the continued court date, Petitioner shall inform the Court on Ms. Penna's position and properly file a declination to serve as executor from Ms. Penna, if appropriate.

**11. PR0000924 In the Matter of Debbie Denise**

Appearances are required. Petitioner shall be prepared to update the Court on the status of the petition to administer and the anticipated length of the requested evidentiary hearing on the petition to determine survival and distribution rights and setting of the same.
