October 17, 2025, Probate Tentative Rulings

1. P05-14145 In the Matter of Jennifer Lee Arvisais

No appearances are required. The court has reviewed and approves the parties' October 14, 2025, stipulation and order. The court grants the conservator's September 29, 2025, petition for instructions and proposed order, modified to indicate that "the Conservator is authorized to follow the recommendations set forth in said POLST, subject to the terms and conditions of the October 14, 2025, stipulation and order." Separately, the conservatorship of the person and estate shall continue. The conservatorship still appears to be warranted. The conservator is acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for September 3, 2027, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.

2. P20-16664 In the Matter of Sandra Robinson

No appearances are required. The court continues this matter to January 16, 2026, at 9:00 a.m., in Department 6, and sets an order to show cause hearing for the same date and time. Conservator shall show cause why they have failed to submit a final accounting as ordered by the court on August 8, 2025. The clerk shall provide notice of the order to show cause hearing to conservator through her counsel, Mr. Keene.

3. PR0000237 In the Matter of Klaus Mathes

No appearances are required. The amended petition for administration is granted as prayed.

4. PR0000357 In the Matter of John Watson

No appearances are required. The second account and report or conservator of the person and estate and petition for fees for conservator and her attorney are granted as prayed. The third and final account and report of conservator of the person and estate and petition for fees for conservator and her attorney are granted as prayed. Proposed orders have been submitted.

5. PR0000453 In the Matter of Suzanne M. Perry-Miller

No appearances are required. The petition for attorney's fees filed by Katie Lenore is granted as prayed. A proposed order has been submitted. The first account of prior conservator Leticia Garcia and petition for approval of conservator and attorney costs and fees, and increase in bond, are granted as prayed. A proposed order has been submitted.

6. PR0000698 In the Matter of Antonio Maresca

No appearances are required. The court continues this matter to January 16, 2026, at 9:00 a.m., in Department 6, and appoints Richard Keene to represent conservatee. The clerk shall inform Mr. Keene of the appointment. The court is favorably inclined to grant the request to appoint Christina De La Casas as a co-conservator in this matter. The court will need to learn the position of the parties as to which rights conservator shall exercise and which shall be retained by conservatee. Petitioner shall provide notice of the

continued court date.

7. PR0000779 In the Matter of Jesus Gabriel Guadalupe Colorado

Appearances are required. The court is inclined to grant the petition for appointment of limited conservator of the person and estate. The court will need to learn the position of the parties as to which rights conservator shall exercise and which shall be retained by conservatee. The first annual review will be set for September 4, 2026, at 9:00 a.m., in Department 6.

8. PR0000819 Conservatorship of the Person of Patricia Stone

No appearances are required. The petition for conservator of the person and estate is granted as prayed. The Nevada County Public Guardian is appointed as conservator and letters shall issue. The first annual review is set for October 16, 2026, at 9:00 a.m., in Department 6.

9. PR0000821 In the Matter of Michael John Gardner

No appearances are required. The petition to administer the estate is granted as prayed. Letters shall issue.

10. PR0000832 In the Matter of Bonnie May McGuire

Appearances are required. The parties shall be prepared to update the court on the status of this litigation and the setting of a will contest as necessary.

11. PR0000871 In the Matter of Billie Dean Nasca Muir

No appearances are required. On its own motion the court continues this matter to January 16, 2026, at 9:00 a.m., in Department 6. The court notes deficiencies in the petition to administer. No appearances are required. The petition to administer the estate is granted as prayed. Letters shall issue once petitioner has lodged the will with the court. *See* Local Rule 8.06.

13. PR0000883 In the Matter of Brian Pisciotta

No appearances are required. The petition for order confirming trust assets is granted as prayed. A proposed order has been submitted.
