

### **October 3, 2025, Probate Tentative Rulings**

1. **P05-14145                    In the Matter of Jennifer Lee Arvisais**  
Appearances are required for argument in connection with the petition for instructions for court authority to change end of life plan.
2. **P06-14335            In the Matter of Rebecca Mary Elizabeth Hengesbach**  
No appearances are required. On its own motion the court continues this matter to December 19, 2025 at 9:00 a.m., in Department 6. Pursuant to California Probate Code section 2105(b) the court can appoint joint conservators, however, each shall qualify in the same manner as a sole conservator. As such, petitioner shall file proof of a citation (Form GC-320) and complete any other requirements for appointment prior to the continued court date. The court appoints the court investigator to complete an investigation and requests that it be done prior to the continued court date.
