

October 31, 2025, Probate Tentative Rulings

1. P14-15675 In the Matter of Carlene Stoneman

On the court's motion, the hearing is continued from October 31, 2025, to November 3, 2025, at 9:30 a.m. in Department 6. No appearances are required. The conservatorship of the person shall continue. The conservatorship still appears to be warranted. The Conservator is acting in the best interests of the Conservatee regarding the Conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for October 29, 2027, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.

2. P17-16181 In the Matter of Andrew Joseph Graybill

On the court's motion, the hearing is continued from October 31, 2025, to November 3, 2025, at 9:30 a.m. in Department 6. No appearances are required. The order to show cause issued to Michael Graybill is discharged in the interests of justice. On the Court's own motion this matter is continued to December 5, 2025, at 9:00 a.m., in Department 6 for confirmation of the transfer to Yuba County Superior Court.

3. P19-16497 In the Matter of Jonathan G. Best

On the court's motion, the hearing is continued from October 31, 2025, to November 3, 2025, at 9:30 a.m. in Department 6. No appearances are required. The petition for approval of account, conservator fees, attorney fees and decrease of bond is granted as prayed. Bond is decreased to \$450,255.09. Conservator shall file proof of the reduced bond with the court. A proposed order has been submitted.

4. PR0000135 In the Matter of Kathy L. McKay

On the court's motion, the hearing is continued from October 31, 2025, to November 3, 2025, at 9:30 a.m. in Department 6. No appearances are required. The Court notes that the inventory and appraisal filed with the Court was not signed by Kevin Eckard, the appointed probate referee. The Court continues this matter to December 12, 2025, at 9:00 a.m., in Department 6. Petitioner shall provide an inventory and appraisal signed by the probate referee prior to the continued court date. The Court is otherwise favorably inclined to grant the petition as requested. Petitioner shall provide notice of the continued court date.

5. PR0000605 In the Matter of Inesis Janis Alberts Day

On the court's motion, the hearing is continued from October 31, 2025, to November 3, 2025, at 9:30 a.m. in Department 6. No appearances are required. The Court continues this matter to December 12, 2025, at 9:00 a.m., in Department 6. The Court notes that no notice was provided for the September 3, 2025, petition for final distribution and that notice on October 25, 2025 was issued to A. Zackainins. Petitioner shall provide notice of the continued court date to all parties entitled to notice. Additionally, the petition for final distribution does not include the requested intestate distribution. Petitioner shall file and serve a declaration no later than two weeks prior to the continued court date indicating the requested intestate distribution.
