# **December 5, 2025, Probate Tentative Rulings**

#### 1. P03-13788 In the Matter of Anna J. E. Larsen

Appearances are required. Conservator Mary Larsen shall show cause why she should not be sanctioned for failure to appear on November 7, 2025 as directed by the Court. Additionally, Conservator shall be prepared to advise the Court regarding her willingness and ability to continue service as Conservator.

The Court is tentatively inclined to enter the following order: The conservatorship of the person shall continue. The conservatorship still appears to be warranted. The Conservator is acting in the best interests of the Conservatee regarding the Conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for November 6, 2026, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.
