

January 26, 2026, Case Management Conference Tentative Rulings

- 1. CL0003359 Navigators Specialty Insurance Co. vs. Michael Andrew Ricaurte**
No appearances are required. On its own motion, the Court continues the case management conference to May 11, 2026, at 9:00 a.m., in Department 6. Plaintiff shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal of Defendant no later than two weeks prior to the continued case management conference date.
