

**December 8, 2025, Case Management Conference Tentative Rulings**

**1. CL0001452      Thomas Duncan Meyers, et al. vs. Ada Mavis Hickey**

No appearances are required. On its own motion, the Court continues the case management conference to March 30, 2026, at 9:00 a.m., in Department 6. Plaintiff shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal for defendant no later than two weeks prior to the continued case management conference date.
