

## **February 13, 2026, Probate Tentative Rulings**

**1. P07-14603 In the Matter of Katie N. Miller**

No appearances are required. The conservatorship of the person and estate shall continue. The conservatorship still appears to be warranted. The Conservators are acting in the best interests of the Conservatee regarding the Conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for February 11, 2028, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.

**2. P21-16976 In the Matter of Nicole Carman**

No appearances are required. The petition for final distribution is granted as prayed. A proposed order has been submitted.

**3. PR0000455 In the Matter of Wade Amesbury**

Appearances are required. The parties shall be prepared to update the Court on the status of pending petition and the setting of a hearing if necessary.

**4. PR0000809 In Re Griffin Wayne Johnson Murphy**

No appearances are required. The Court continues this matter to April 24, 2026, at 9:00 a.m., in Department 6 and sets an order to show cause hearing for the same date and time. Guardian Allyson Siobhan Johnson shall show cause why she should not be sanctioned for her failure to file an inventory and appraisal as ordered by the Court on November 10, 2025 and required by Cal. Probate Code section 2610.

**5. PR0000830 In the Matter of the John C. and Idee M. Morales Trust**

No appearances are required. The petition to approve first account is granted as prayed. Counsel for Petitioner shall submit a proposed order.

**6. PR0000924 In the Matter of Debbie Denise**

No appearances are required. The amended petition for administration is granted as prayed. A proposed order has been submitted. All future dates are confirmed.

**7. PR0000926 In the Matter of Lloyd Nelson**

No appearances are required. The petition to administer is granted as prayed. A proposed order has been submitted.

**8. PR0000933 In the Matter of Jody McCaffree**

No appearances are required. The petition for accounting, removal of trustee, appointment of successor trustee and award of attorney fees is continued to April 24, 2025, at 9:00 a.m., in Department 6. The Court finds that "notice otherwise required [and given] is insufficient in the particular circumstances" of this case. Probate Code §1202. Petitioner shall personally serve the petition on Trustee True prior to the continued court date. Petitioner also shall provide notice of the continued court date.

**9. PR0000934 In Re Patricia Francis Stone**

No appearances are required. The petition for appointment of probate conservator of the person and estate is denied. A conservatorship for the proposed conservatee has already been established in case PR0000819 and letters have issued.

**10. PR0000935 In the Matter of Eileen Raether**

No appearances are required. The petition for order confirming trust assets is granted as prayed. Petitioner shall provide a proposed order to the Court.

**11. PR0000945 In the Matter of Paul Reynolds**

No appearances are required. The petition to determine succession to primary residence is granted as prayed. Petitioner shall provide a proposed order.
