

## **February 6, 2026, Probate Tentative Rulings**

### **1. P05-14149 In the Matter of Wesley B. James**

No appearances are required. The conservatorship of the person shall continue. The conservatorship still appears to be warranted. The Conservator is acting in the best interests of the Conservatee regarding the Conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for November 19, 2027, at 9:00 a.m., in Department 6. The court investigation fee for this biennial review is waived.

### **2. PR0000475 In the Matter of Michael Bond**

No appearances are required. Petitioner has not provided a proof of service for Dalton Workman regarding the petition to recover property as previously directed by the Court. Accordingly, the Court continues that matter to April 17, 2026, at 9:00 a.m., in Department 6 to provide additional time for service.

Separately, the petition for confirmation of sale of personal property is granted as prayed. No objection to the same has been filed with the Court. Administrator is permitted to complete the sale of the 2016 Dodge Ram truck to Kelli Prochaska for the full appraisal value of \$27,000. Petitioner shall provide a proposed order.

### **3. PR0000653 In the Matter of Pamela Garwood**

No appearances are required. The first account and report and petition for fees is granted as prayed. A proposed order has been submitted.

### **4. PR0000783 In the Matter of Brian Bennett**

No appearances are required. The Court sets a further review hearing regarding transfer of venue on April 17, 2026, at 9:00 a.m., in Department 6. Upon receipt of confirmation of transfer this date shall be vacated by the Clerk unless ordered otherwise.

### **5. PR0000832 In the Matter of Bonnie May McGuire**

No appearances are required. The motion to be relieved filed by Counsel Harpainter is granted. A proposed order has been submitted. Mr. Harpainter is relieved as counsel of record for Marguerite DeMartini effective upon the filing of the proof of service of the signed order upon the client. The hearing for March 6, 2026, is confirmed. Ms. DeMartini shall be prepared at the next hearing to indicate whether she has retained new counsel or will represent herself.

### **6. PR0000867 In the Matter of Kathleen A. Boom**

Appearances are required. The petition to administer filed by David Boom is granted as prayed. Letters shall issue. The Court grants the request to overrule the objections filed by Pamela Wilde, Rosalie Morris and Dawn Crockell. None of the objections are verified as required by law and the Court therefore declines to address them. *See Prob. Code § 1021, In re Estate of Beard*, (1999) 71 Cal. App. 4th 753, 780. A proposed order has been submitted.

**7. PR0000918 In the Matter of Robert Earl Cole**

No appearances are required. The Court has not received the court investigation report. The Court continues this matter for receipt of the report to April 17, 2026, at 9:00 a.m., in Department 6. The Clerk shall provide a copy of the minutes to the Court Investigator. The Clerk shall also telephonically notify the Court Investigator.

**8. PR0000923 In the Matter of Janet L. Windz**

No appearances are required. This hearing was improvidently left on calendar and is vacated.

**9. PR0000925 In the Matter of Jared Marshall Holt**

No appearances are required. The petition for order confirming trust assets is granted as prayed. A proposed order has been submitted.

**10. PR0000927 In the Matter of Jane Rebecca Binks**

No appearances are required. The petition for removal of trustee and for surcharge damages for breach of fiduciary duty is continued to April 17, 2025, at 9:00 a.m., in Department 6. The Court finds that “notice otherwise required [and given] is insufficient in the particular circumstances” of this case. Probate Code §1202. Petitioner shall personally serve the petition on Waites prior to the continued court date. Petitioner also shall provide notice of the continued court date.

**11. PR0000928 In the Matter of Morgan Powelson**

No appearances are required. The petition to determine succession to primary residence is granted as prayed. Petitioner shall provide a proposed order.

**12. PR0000929 Estate of Asher Robertson**

No appearances are required. The petition to administer the estate is granted as prayed. A proposed order has been provided.
