

## March 30, 2026, Case Management Conference Tentative Rulings

- 1. CL0001452      Thomas Duncan Meyers, et al. vs. Ada Mavis Hickey**  
No appearances are required. On its own motion, the Court continues the case management conference to July 13, 2026, at 9:00 a.m., in Department 6. Plaintiff shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal of defendant no later than two weeks prior to the continued case management conference date.
- 2. CL0002584      Geico General Insurance Company vs. Sebastian Deleon-Mariscal, et al.**  
Appearances are required. Plaintiff shall show cause why they should not be sanctioned for failure to file a proof of service, an application to serve by publication (if deemed appropriate), or a request for dismissal for defendant Delean-Mariscal as previously ordered by this Court on September 22, 2025.
- 3. CL0002939      Fidelity National Title Company vs. Ronald D. Pitts, et al.**  
No appearances are required. On the Court's motion, the case management conference is continued to July 17, 2026, at 9:00 a.m., in Department 6. No party has filed a timely case management conference statement and all are admonished that failing to file a statement in the future may result in sanctions.
- 4. CL0003054      Midland Credit Management Inc. vs. Michelle Vasquez**  
Appearances are required for status regarding dismissal. If the parties wish the Court to retain jurisdiction, they should file a written stipulation under Code of Civil Procedure section 664.6 or state their agreement regarding the same on the record.
- 5. CL0003256      JPMorgan Chase Bank N.A. vs. Amelya Gross**  
No appearances are required. The Court dismisses this matter without prejudice and retains jurisdiction pursuant to California Code of Civil Procedure 664.6.
- 6. CU0001163      Rikki Rockett vs. Mountain Valley Child & Family Services**  
Appearances are required for status regarding dismissal. If the parties wish the Court to retain jurisdiction, they should file a written stipulation under Code of Civil Procedure section 664.6 or state their agreement regarding the same on the record.
- 7. CU0001540      Bradley Dorigo, et al. vs. County of Nevada**  
No appearances are required. On its own motion, the Court continues the case management conference to July 13, 2026 at 9:00 a.m., in Department 6. The Court sustained Defendants' demurrer without leave to amend. Defendants shall file a judgment of dismissal prior to the continued case management date.

**9. CU0001780 Elliott Allen Roberts vs. Austin Wallace**

No appearances are required. On its own motion, the Court continues the case management conference to July 13, 2026, at 9:00 a.m., in Department 6. The Court notes the prior stay is no longer in effect. Defendant Wallace shall file a responsive pleading, or Plaintiff shall file a request for default (as appropriate) or request for dismissal of Defendant at least two weeks prior to the continued case management conference.

Additionally, a cross-complaint has been filed. Cross-complainant Wallace shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal of cross-defendant no later than two weeks prior to the continued case management conference date.

**10. CU0001793 Jamie Davidson vs. Bluebell Holdings, LLC**

Appearances are required for status regarding dismissal. If the parties wish the Court to retain jurisdiction, they should file a written stipulation under Code of Civil Procedure section 664.6 or state their agreement regarding the same on the record.

**11. CU0002023 Wendy Jean Robinson Jr v. Shellpoint Mortgage Servicing, et al.**

No appearances are required. On its own motion, the Court continues the case management conference to July 13, 2026, at 9:00 a.m., in Department 6. A first amended complaint has recently been filed. Defendant shall file a responsive pleading, or Plaintiff shall file a request for default (as appropriate) or request for dismissal of Defendant prior to the continued case management conference.

**12. CU0002080 Daniel Batchelor vs. Leroy W. Rodde**

Appearances are required for status regarding dismissal. If the parties wish the Court to retain jurisdiction, they should file a written stipulation under Code of Civil Procedure section 664.6 or state their agreement regarding the same on the record.

**13. CU0002182 In the Matter of County of Nevada**

No appearances are required. This date was improvidently left on calendar. The Court confirms the previously set April 3, 2026 hearing date and May 1, 2026 case management conference date.

**14. CU0002188 Cassandra Jordan v Ingrid Larson, et al.**

No appearances are required. On the Court's motion, the case management conference is continued to July 13, 2026, at 9:00 a.m., in Department 6, to permit adjudication of pending motions.

**15. CU0002203 Eva Schauffler v. Gregory W. Klein, et al.**

Plaintiff shall show cause why she should not be sanctioned for failing to file a request for default or request for dismissal of defendant as ordered by this Court on December 8, 2025. The Clerk shall provide notice of the order to show cause.

**17. CU0002313 Jason Christ vs. Target Corporation**

No appearances are required. On its own motion, the Court continues the case management conference to July 13, 2026, at 9:00 a.m., in Department 6. A first amended complaint has recently been filed. Defendant shall file a responsive pleading, or Plaintiff shall file a request for default (as appropriate) or request for dismissal of Defendant prior to the continued case management conference.

Additionally, Plaintiff has filed a request regarding access to evidence obtained by Grass Valley Police Department. The Court declines to address that request without prejudice. Plaintiff is directed to file a noticed motion, served on all parties, on the Court's motion calendar.

No appearances are required. This case is at issue. Jury fees are paid.
