1. CL0002939 Fidelity National Title Company vs. Ronald D. Pitts, et al.

No appearances are required. On its own motion, the Court continues this matter to October 26, 2026, at 9:00 a.m., in Department 6, and sets an order to show cause hearing for the same date and time. All parties shall show cause why they should not be sanctioned for failing to timely file a case management conference statement. The clerk shall serve notice of the order to show cause.
