

July 31, 2026, Probate Tentative Rulings

1. P06-14321 In the Matter of Chad D. Hanson

No appearances are required. The Court has not received the investigation review report and continues this matter to October 30, 2026, at 9:00 a.m., in Department 6. The Clerk shall provide a copy of the minutes to the Court Investigator. The Clerk shall also telephonically notify the Court Investigator.

2. P69-07222 In the Matter of Allison F. Oswald

No appearances are required. The Court has not received the investigation review report and continues this matter to October 30, 2026, at 9:00 a.m., in Department 6. The Clerk shall provide a copy of the minutes to the Court Investigator. The Clerk shall also telephonically notify the Court Investigator.
