

July 13, 2026, Case Management Conference Tentative Rulings

1. CL0001452 Thomas Duncan Meyers, et al. vs. Ada Mavis Hickey

No appearances are required. On its own motion, the Court continues this matter to October 26, 2026, at 9:00 a.m., in Department 6, and sets an order to show cause hearing for the same date and time. Plaintiff shall show cause why they should not be sanctioned for failing to file a proof of service, an application for service by publication (as appropriate), or a request for dismissal of defendants as ordered by this Court on March 30, 2026. The clerk shall serve notice of the order to show cause.

2. CL0003995 Sierra Plumbing Supply Inc. v. Bert McWhinney

No appearances are required. It does not appear that Plaintiff is represented by counsel. In California, “[A] corporation cannot represent itself in a court of record either in propria persona or through an officer or agent who is not an attorney.” (*Caressa Camille, Inc. v. Alcoholic Beverage Control Appeals Bd.* (2002) 99 Cal. App. 4th 1094, 1101.) On its own motion, the Court continues the case management conference to October 26, 2026, at 9:00 a.m., in Department 6. Prior to the continued court date, counsel of record for Plaintiff shall file a substitution of attorney or notice of representation, or Plaintiff shall inform the Court on the status of obtaining representation. Plaintiff is ordered to provide notice of the continued court date.

3. CU0001323 Ryan Shirley vs. Dynasty Valley, LLC

No appearances are required. On the Court’s motion, the case management conference is continued to October 26, 2026, at 9:00 a.m., in Department 6, to permit adjudication of pending motions.

4. CU0001540 Bradley Dorigo, et al. vs. County of Nevada

No appearances are required. This date was improvidently left on calendar and is dropped from calendar.

No appearances are required. On its own motion, the Court continues this matter to October 26, 2026, at 9:00 a.m., in Department 6, and sets an order to show cause hearing for the same date and time. Plaintiff shall show cause why they should not be sanctioned for failing to file a proof of service, an application for service by publication (as appropriate), or a request for dismissal of defendants as ordered by this Court on March 2, 2026. The clerk shall serve notice of the order to show cause.

10. CU0001972 Cynthia Carter vs. Stone House, LLC, et al.
