

### **July 21, 2025 Case Management Conference Tentative Rulings**

1. CL0002331      United Financial Casualty Company vs. Katie Powers  
Appearances are required. Plaintiff shall show cause why they should not be sanctioned or this matter dismissed for failing to file a proof of service, an application for publication (as appropriate) or a request for dismissal for defendant Powers as ordered by this court on March 17, 2025.
2. CL0002463      Progressive Select Insurance Company vs. Nichole Anderson  
No appearance is required. On the court's own motion, the case management conference is continued to October 13, 2025, at 9:00 a.m. in Department 6. An order to show cause hearing is set for the same date and time for plaintiff to show cause why it has not filed a proof of service, an application to serve by publication (if deemed appropriate), or a request for dismissal as previously ordered by this court on May 12, 2025.
3. CL0002737      Peters' Drilling & Pump Service, Inc. vs. Nathaniel McFarland, et al.  
No appearances are required. On its own motion, the court continues the case management conference to October 13, 2025, at 9:00 a.m. in Department 6. Plaintiff shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal of defendants no later than two weeks prior to the continued case management conference.
4. CU0000569      Susan Foote vs. Jenny Renee Hunter Kaeding  
No appearances are required. On its own motion, the court continues the case management conference to October 13, 2025, at 9:00 a.m. in Department 6. The court is in receipt of defendant's declaration, dated June 10, 2025, indicating the bankruptcy matter has been adjudicated. Defendant shall file and serve the appropriate motion in advance of the continued case management conference date.
5. CU0001160      Abdullah Awadalla et al vs. Gina Cataldo, et al.  
Appearances are required for status regarding dismissal. If the parties wish the court to retain jurisdiction, they should file a written stipulation under Code of Civil Procedure section 664.6 or state their agreement regarding the same on the record.
6. CU0001760      In the Matter of County of Nevada  
Appearances are required. The court seeks an update from the parties on the status of the property.
7. CU0001787      Carol Lynn Hills v. State of California  
Appearances are required. Plaintiff shall show cause why she should not be sanctioned or this matter dismissed for failing to file a proof of service, an application for publication (as appropriate) or a request for dismissal for defendant State of California as ordered by this court on March 17, 2025.

No appearances are required. On its own motion, the court continues the case management conference to October 13, 2025, at 9:00 a.m. in Department 6. Plaintiff shall file proof of service, an application for service by publication (as appropriate), or a request for dismissal of defendants Condor Flugdienst BSP and GmbH, no later than two weeks prior to the continued case management conference. Additionally, defendants Justfly Corp., Justfly INC., and American Express Company, shall file a responsive pleading, or plaintiff shall file a request for default (as appropriate) or request for dismissal of defendants at least two weeks prior to the continued case management conference. Plaintiff shall serve notice of the continued case management conference.
10. CU0002045      California Fair Plan Association vs. Gregory James Gallup, et al.  
No appearances are required. This case is at issue.
