

August 15, 2025 Amended Probate Tentative Rulings

1. P11-15266 In the Matter of Donald W Young, et al.
No appearances are required. The petition for settlement of the fourteenth accounting and approval of trustee fees is granted as prayed.
2. PR0000117 In Re Christopher Hogue
No appearances are required. The court has received the first account and report of conservator. However, the petition lacks notice and proof of service. The court continues the order to show cause hearing to October 10, 2025 at 9:00 a.m. in Department 6. Conservator shall provide notice and proof of service of the accounting prior to the continued court date.
3. PR0000538 In the Matter of Tamara Cranwell
No appearances are required. The court has received the report from the conservator regarding the sale of the home and the placement of conservatee. No further review hearing is necessary.
4. PR0000593 In the Matter of Christopher Lopiccolo
No appearances are required. The court is favorably inclined to grant the petition for final distribution as prayed, however, creditor claims have been filed by the following entities; Wells Fargo Bank N.A., Capital One, N.A. Quicksilver and USAA Savings Bank. The petition does not address the status of these claims in compliance with Cal. Rule of Court 7.403. No appearances are required. The petitioner for final distribution on approval of account, and for payment of executor and attorney fees is granted as prayed.
6. PR0000795 In the Matter of Vincent Andrew Burkhart
No appearances are required. The court continues this matter to October 10, 2025, at 9:00 a.m. in Department 6. The court orders a court investigative report to be completed.
