

August 3, 2026, Case Management Conference Tentative Rulings

1. CL0003562 Jefferson Capital Systems LLC vs. Anne Lucq

Appearances are required. All parties shall show cause why this action should not be dismissed, without prejudice, and with retention of jurisdiction, pursuant to Code of Civil Procedure section 664.6(e), in light of the April 8, 2026, notice of conditional settlement.
