# September 19, 2025 Case Management Conference Tentative Rulings

### 1. CL0001165 Victor Navarrete vs. Jennin Valentine Martinez, et al.

No appearances are required. On its own motion, the Court continues the case management conference to October 17, 2025, at 9:00 a.m. in Department A. All parties shall submit timely case management conference statements in advance of the next court date. This case is at issue and all parties are advised that the Court intends to set trial dates. Appearances at the next court date will be required.

### 2. CL0002556 Cleanrite, Inc. vs. Seth Warren

As these parties have appeared at MSC one time (albeit absent defendant Vaysman), the Court will entertain excusing the parties from further MSC in the event the parties provide a written stipulation and proposed order agreeing to participate in private mediation.

The Court admonishes defendant Vaysman and cross-defendants as to their failure to file a Case Management Conference Statement.

The Court wishes to advise the parties it has reviewed their respective CMC Statements and has set dates according to their availability. However, the Court finds it unreasonable for counsel for defendants to assert unavailability for ten out of the next twelve months. This case has been pending since May of 2024.
