# September 5, 2025, Probate Tentative Rulings

### 1. P05-14145 In the Matter of Jennifer Lee Arvisais

No appearances are required. The court has not received the investigation review report. The court continues this matter for receipt of the report to December 5, 2025, at 9:00 a.m. in Department 6. The clerk shall provide a copy of the minutes to the court investigator. The clerk shall also telephonically notify the court investigator.

# 2. P17-16181 In the Matter of Andrew Joseph Graybill

Appearances are required. The court seeks an update on the status of the court's order granting the transfer of proceedings to Yuba County and whether transfer has been accepted by said county.

# 3. PR0000667 In the Matter of Cynthia E. Dell

No appearances are required. A written ruling issued on September 4, 2025 with respect to the bench trial. The ruling scheduled for September 5, 2025, is vacated. This matter is set for status on September 19, 2025, at 9:00 a.m. in Department 6.

#### 4. PR0000756 In The Matter of Violet Weston

No appearances are required. The court continues this matter to December 5, 2025, at 9:00 a.m. in Department 6. The court notes a number of deficiencies in the petition for appointment. The amended citation (GC-320) filed by petitioner is not signed by the party who served the citation. Petitioner can either submit an amended citation completed by the party who served the citation, or a new citation must be filed and served. Petitioner has filed an amended notice; however, only proposed conservatee's attorney and Brian Weston were served. Pursuant to Cal. Probate Code section 1822(b)(2), notice shall also be provided to all relatives named in the petition. Petitioner shall provide notice of the continued court date to all who are entitled notice by law.

Finally, based on the report of the court investigator and the report of the court appointed attorney for the proposed conservatee, the court is inclined to designate this request as a request for limited conservatorship pursuant to Probate Code section 1800.3(d) based on the proposed conservatee's developmental disability. Therefore, the court orders petitioner to provide notice to Alta Regional Center pursuant to Probate Code section 1461.4 and further directs Alta Regional Center prepare a report and recommendation for the court's consideration. The clerk shall also provide a copy of the minutes to Alta Regional Center.

# 5. PR0000779 In the Matter of Jesus Gabriel Guadalupe Colorado

No appearances are required. The court has not received the Alta Regional Center report. The court continues this matter for receipt of the report to October 17, 2025, at 9:00 a.m. in Department 6. Alta Regional Center shall submit their report prior to the continued court date. The clerk shall provide a copy of the minutes to Alta Regional Center.

#### 6. PR0000785 In the Matter of Diana Dentoni

No appearances are required. The petition for surcharge, accounting, damages and other relief for breach of fiduciary duty is denied.

Petitioner is a beneficiary of the Mary Elizabeth Dentoni Revocable Trust. Patrick Gilmore is the trustee of the trust. Trustee Gilmore caused the trust asset located at 517 Packard Drive, Grass Valley, California, to be sold. He thereafter distributed the proceeds from that sale to the beneficiaries. Petitioner accepted the distribution and signed a waiver of right to contest the action. Having signed the waiver, petitioner cannot now contest the distribution or the circumstances of trustee's election to sell the property. *See* Probate Code §16464.

Additionally, petitioner received an accounting from the trustee on April 15, 2024. The trust provides that, "Upon receipt of an account by the trustee, a beneficiary has 180 days to make any objection to such account or to make any claim against the trustee for matters adequately disclosed in such account." Trust Article 6 section 6.2(p). More than 180 days have elapsed since petitioner received the accounting; accordingly, petitioner's ability to request such an account has expired.

# 7. PR0000828 In the Matter of Craig Stuart Murdoch

No appearances are required. The court continues this matter to December 5, 2025, at 9:00 a.m. in Department 6. Proof of publication is required. Petitioner shall submit the proof of publication no later than two weeks prior to the continued court date. Petitioner shall provide notice of the continued court date.

### 8. PR0000831 In the Matter of Myrna LeFern Buettner

No appearances are required. The petition to determine succession to primary residence is denied without prejudice. A probate matter concerning this estate is presently pending in PR0000815. Accordingly, the court is unable to grant this request. *See* Probate Code section 13150. The clerk shall provide a copy of the minutes to petitioner.

## 9. PR0000834 In the Matter of Olivia T. Diaz

No appearances are required. The petition to administer the estate is granted as prayed.

#### 10. PR0000835 In the Matter of Laura Beth Proffit

No appearances are required. The petition to establish fact, date and place of marriage is granted as prayed. Petitioner shall file a proposed order.
