

September 21, 2026, Case Management Conference Tentative Rulings

- 1. CL0004266 Rexel USA, Inc. vs. Stephen J. Sprague, et al.**
No appearances are required. On its own motion, the Court continues the case management conference to December 28, 2026, at 9:00 a.m., in Department 6. Plaintiff shall file a proof of service, an application for service by publication (as appropriate), or a request for dismissal of Defendants no later than two weeks prior to the continued case management conference date.
