## August 1, 2025 Probate Tentative Rulings

- 1. In the Matter of Wilfred Martinez
  No appearances are required. The eleventh account and report of the former conservator
  of the estate is granted as prayed. Bond is increased to \$300,000. Petitioner shall file
  receipt of a bond with the court. A proposed order has been submitted.
- 2. P11-15182 In the Matter of Jacquelyn Munoz
  No appearances are required. The court continues this case to September 12, 2025 at
  9:00 a.m. in Department 6 and sets an order to show cause hearing for the same date and
  time. Petitioner Salvato shall show cause for her failure to file a proof of service as
  directed by this court on May 9, 2025. Additionally, Petitioner Salvato shall show cause
  for her failure to file proof that conservatorship proceedings have been initiated in Idaho
  as directed by this court on May 9, 2025. The clerk shall provide notice of the order to
  show cause.

Separately, the court has reviewed the investigation report. The limited conservatorship of the person shall continue. The conservatorship still appears to be warranted. The conservator is acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for July 9, 2027, at 9:00 a.m. in Department 6. The court investigation fee for this biennial review is waived.

- 3. P14-15596 In the Matter of Jane K. Fraser No appearances are required. The conservatorship of the person shall continue. The conservatorship still appears to be warranted. The conservators are acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for June 11, 2027, at 9:00 a.m. in Department 6. The court investigation fee for this biennial review is waived.
- 4. P22-16995 In the Matter of Phyllis Graham No appearances are required. The petition to approve the second and final accounting is granted as prayed. As to Petitioner's request to distribute the estate pursuant to Cal. Probate Code section 13100, the court was unable to locate an affidavit or declaration which satisfied all requirements under section 13101. The court continues this matter to September 12, 2025 at 9:00 a.m. in Department 6. Petitioners shall submit an affidavit in compliance with section 13101 in advance of the continued court date. Petitioners shall provide notice of the continued date.

The order to show cause previously issued is vacated in the interest of justice.

5. PR0000326 In the Matter of Jamie Dickerson No appearances are required. The conservatorship of the person and estate shall continue. The conservatorship still appears to be warranted. The conservators are acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment. The next biennial review is set for May 14, 2027, at 9:00 a.m. in Department 6. The court investigation fee for this biennial review is waived.

Additionally, the court continues this case to September 12, 2025 at 9:00 a.m. in Department 6 and sets an order to show cause hearing for the same date and time. Conservators shall show cause for their failure to file an accounting as ordered by this court on May 30, 2025. The clerk shall provide notice of the order to show cause.

6. PR0000532 In Re Jacob Allen Bieker Appearances are required. Petitioner shall show cause for his failure to appear on May 30, 2025 as directed.

The court is favorably inclined to grant the petition as prayed. The court first intends to confirm with the intestate heirs their waiver/assignment of rights as to the parcels of real property.

7. PR0000645 In Re Walter Mari Ingram Appearances are required. The petition for order accepting transfer is granted. The conservatorship of the person and estate shall continue in California. The conservatorship appears to be warranted. The conservators are acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment, and as well as the conservatee's estate. Upon review of the conservatorship order granted by the state of Nevada, the court is inclined to strike "Powers over Person #2" permitting the use of law enforcement for placement in a secured facility. Should the conservatee require placement in a secured facility, the conservators shall seek approval from the court. The next annual review is set for February 27, 2026, at 9:00 a.m. in Department 6. The court investigation fee is due forthwith. An annual accounting shall be filed prior to the next annual review.
