### June 16, 2025 Case Management Conference Tentative Rulings

## 1. CL0000572 Gerry Reis v. Roger Reis

No appearances are required. On the court's motion, the case management conference is continued to September 15, 2025, at 9:00 a.m. in Department 6 to permit pending motions to be adjudicated. The pending order to show cause issued to Gerry Reis is discharged in the interest of justice.

### 2. CL0001259 Thomas Deal v. Fred Gerkensmeyer, et al.

On the court's motion, the case management conference is continued to September 15, 2025, at 9:00 a.m. in Department 6. It is unclear whether this matter is at issue. The June 13, 2024, first amended complaint (FAC) is the operative complaint; the second amended complaint was stricken.
