1. CU0000316 Mardi Fisher v. Brandon Williams, et al.

No appearances are required. The request for approval of the referee plan is granted as prayed. A proposed order has already been submitted.

2. P07-14542 In the Matter of Michael A Powers, et al.

No appearances are required. The court continues this matter to August 27, 2025 at 9:00 a.m. in Department 6. The court seeks clarity from the trustee on the property on hand at the end of the reporting period. Trustee shall file a declaration no later than 2 weeks prior to the continued date clarifying the financial state of the trust at the close of the reporting period. Trustee shall give notice of the continued date to all parties.

3. P15-15875 In the Matter of Sharon Beatty

Appearances are required. The court will hear argument limited to no more than five minutes per side regarding the petition to remove Lori Greeninger and appoint Mark Dobson as personal representative. to be warranted. The conservators are acting in the best interests of the conservatee regarding the conservatee's placement and quality of care, including physical and mental treatment, and as well as the conservatee's estate. The next annual review is set for February 27, 2026, at 9:00 a.m. in Department 6. The court investigation fee is due forthwith. An annual accounting shall be filed prior to the next annual review.

Petitioner shall also lodge a proposed order for appointment of a court investigator no later than June 24, 2025. Petitioner shall give notice of the continued court date as required by law.

The court appoints the court investigator to complete an investigation report. The clerk shall provide a copy of the minutes to the court investigator and telephonically notify the court investigator. Additionally, the court appoints Richard Keene, Esq., to represent the proposed conservatee. The clerk shall send notice to Mr. Keene.

14. PR0000770 In the Matter of Roy Bernards

No appearances are required. The court has not received the investigation report. The court continues this matter for receipt of the report to August 27, 2025, at 9:00 a.m. in Department 6.
