

September 14, 2026 Truckee Probate Tentative Rulings

1. PR0000552 In Re the Matter of: Thomas Irving Fulton

Petition granted as prayed. Letters shall issue upon Order being signed and filed.

2. PR0000559 In the Matter of Natalie Pearl Seipp

No appearance is required. The Court finds notice has been given as required by law. Guardianship of the estate of the minor remains necessary and convenient and in the minor's best interests. The second annual accounting and corresponding Petition is approved as prayed. The next review date in this matter is set for September 13, 2027 at 1:30 p.m. in Dept. A. The 3rd accounting shall be filed fifteen (15) days prior to the hearing date.

3. PR0000769 In the Matter of Griffin Merritt Seipp

No appearance is required. The Court finds notice has been given as required by law. Guardianship of the estate of the minor remains necessary and convenient and in the minor's best interests. The first annual accounting and corresponding Petition is approved as prayed. The next review date in this matter is set for September 13, 2027 at 1:30 p.m. in Dept. A. The 2nd accounting shall be filed fifteen (15) days prior to the hearing date.

4. PR0000570 In Re Matsumoto, Jyou

The Court has not received the investigation review report and continues this matter to October 12, 2026, at 1:30 p.m., in Department A. The Clerk shall provide a copy of the minutes to the Court Investigator.

5. PR0001068 In the Matter of KELLY CIARUFFOLI

Personal appearances are required.

On May 13, 2026, Kelly Ciaruffoli filed a Petition for Internal Affairs of a Trust, asking the Court to compel an accounting; compel the trustee to provide the beneficiary information relative to his share; compel the trustee to distribute the trust; and order the trustee to pay Petitioner's attorney's fees and surcharge the trustee for attorney's fees and any loss to the trust for breaches of the trust.

No written objections have been filed. Any Respondents desirous to object to a Petition must file a written objection before the hearing. The court has authority to require all objectors to file a written objection pursuant CRC, Rule 7.801, or else deem the failure to do so a waiver.

Absent objection, the Petition will be approved. Petitioner shall file a proposed order prior to the hearing for the Court's review.

6. PR0001153 In Re Rangel-Fuerte, Marco Anthony

No appearances are required. On the Court's motion, this matter is continued to November 9, 2026, at 1:30 p.m., in Department A. The petition does not include a completed capacity declaration (see Form GC-335). Petitioner shall submit any outstanding forms prior to the continued court date. Additionally, the Court appoints Katie Lenore as counsel for the proposed conservatee. The Clerk shall notify Ms. Lenore of the appointment and provide a copy of the minutes. Finally, the Court seeks a report from the court investigator. Petitioner is requested to submit a proposed order appointing the court investigator (see Form GC-330). The court investigator is requested to provide an investigation report prior to the continued court date.

7. TP22-8076 In the Matter of KEIRA JEANNE MILLER

No appearance is required. The current guardianship of the minor remains reasonable, necessary, and in the minor's best interests. The next biennial Review is set for September 11, 2028 at 1:30 p.m. in Dept. A. An updated Guardianship Status Report shall be filed by the Guardian thirty (30) days prior to the review hearing.
